On behalf of the West Virginia Public Employees Grievance Board and in accordance with *West Virginia Code* § 6C-3-3, I am pleased to submit the Grievance Board's Annual Report for Fiscal Year 2016.

The report provides the following data:

- The number of grievances against each employer;
- The types of grievances, level of resolution and costs;
- The number of grievances granted, denied or resolved by other means; and
- The caseload of each administrative law judge, the type of grievance, the number of grievances resolved and the number of decisions issued.

During Fiscal Year 2016, 1,762 new grievances were filed at either Level One or Level Three. Please note that post-filing consolidation results in fewer proceedings than the number of original grievances.

During Fiscal Year 2016, 187 appealable decisions were issued. The average number of days from date of maturity to date of issue was 30.34.

During Fiscal Year 2016, 53 Level 2 Mediations were closed as Successful and 45 were closed as Unsuccessful but were not appealed to Level 3. With the average total cost of a Level 3 hearing of \$5,326.86, these 98 mediations represent a cost avoidance (of a Level 3 hearing) of more than \$522,032.28.
